SHOT AND WOUNDED VICTIMS OF THE NIGERIAN ARMY (JOINED BY POLICE AND OTHERS) MASSACRE OF 29<sup>th</sup> AND 30<sup>th</sup> MAY 2016 DURING THE IGBO-BIAFRA HEROES DAY IN ANAMBRA STATE, SOUTHEAST NIGERIA

**Summary:** In the massacre that took place on 29<sup>th</sup> and 30<sup>th</sup> of May 2016, the Nigerian Army led by Its Chief of Staff, Lt Gen Tukur Yusuf Buratai, joined by Police and ors killed over 140 unarmed, nonviolent and defenseless Pro Biafra Campaigners and other Igbo citizens and shot and critically injured over 130 others. The victims were part of thousands of unarmed Igbo citizens who gathered at Nkpor and Onitsha (Anambra State) and Asaba (Delta State) to mark the 2016 Biafra/Igbo Heroes Day. No fewer than 110 deaths were recorded in Anambra State and 30 in Asaba, Delta State

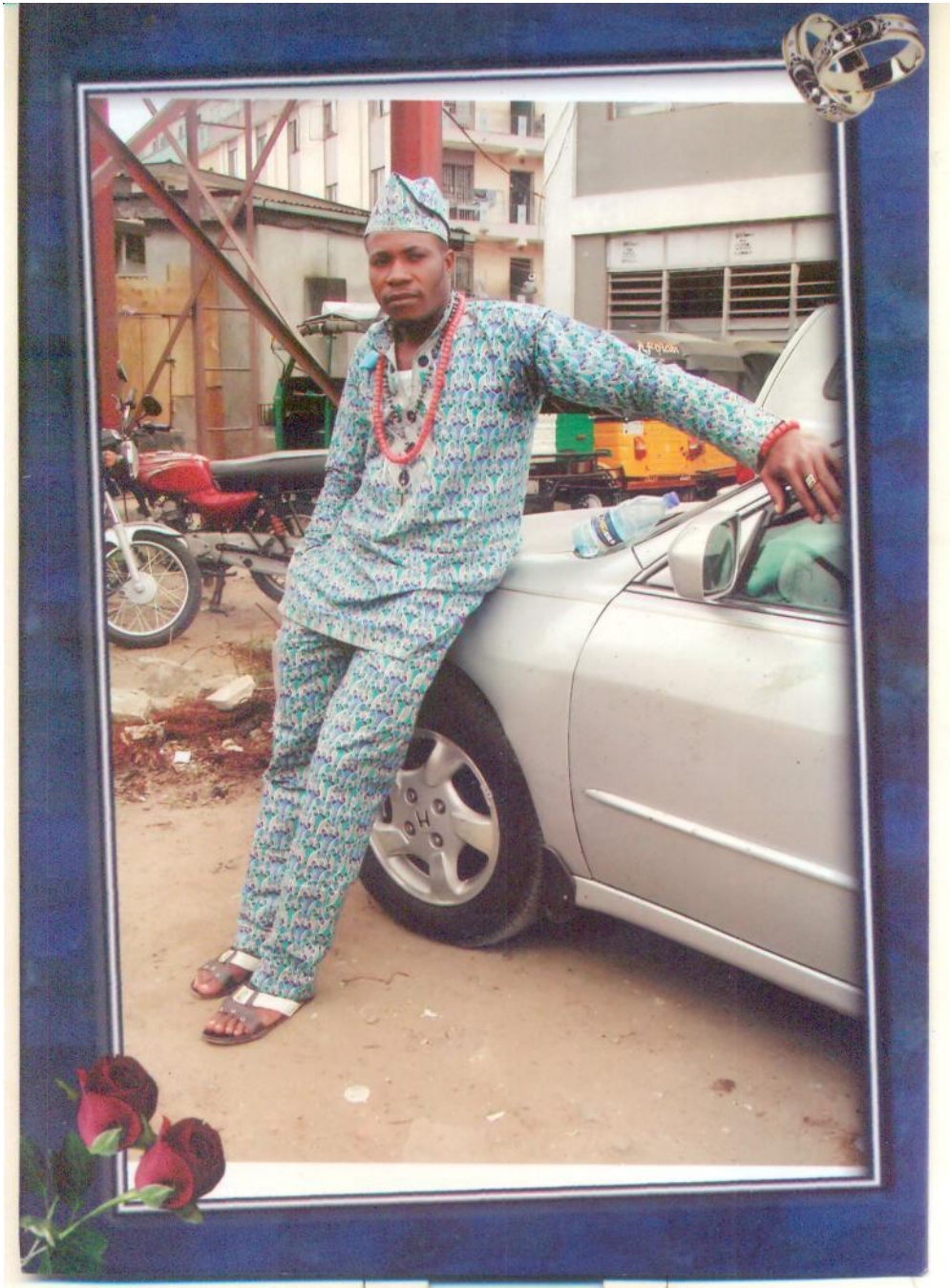

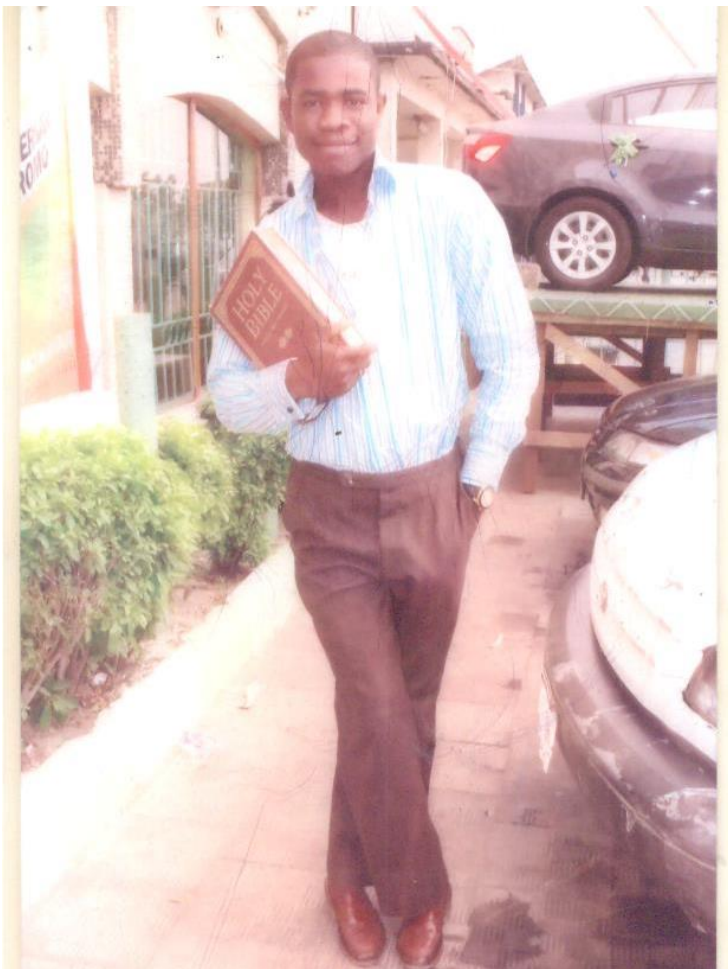

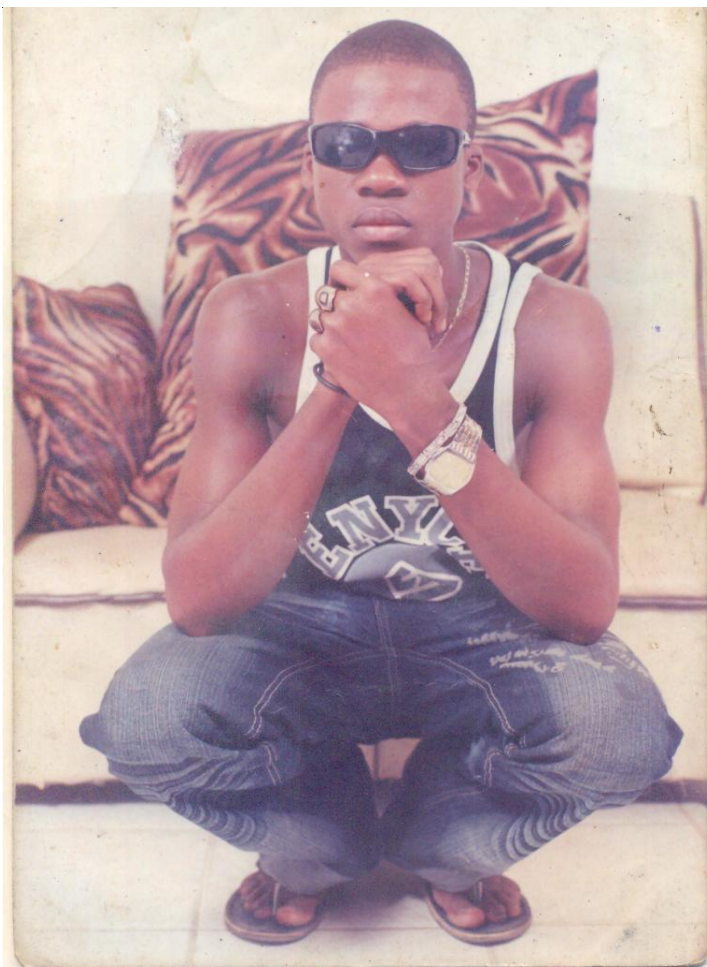

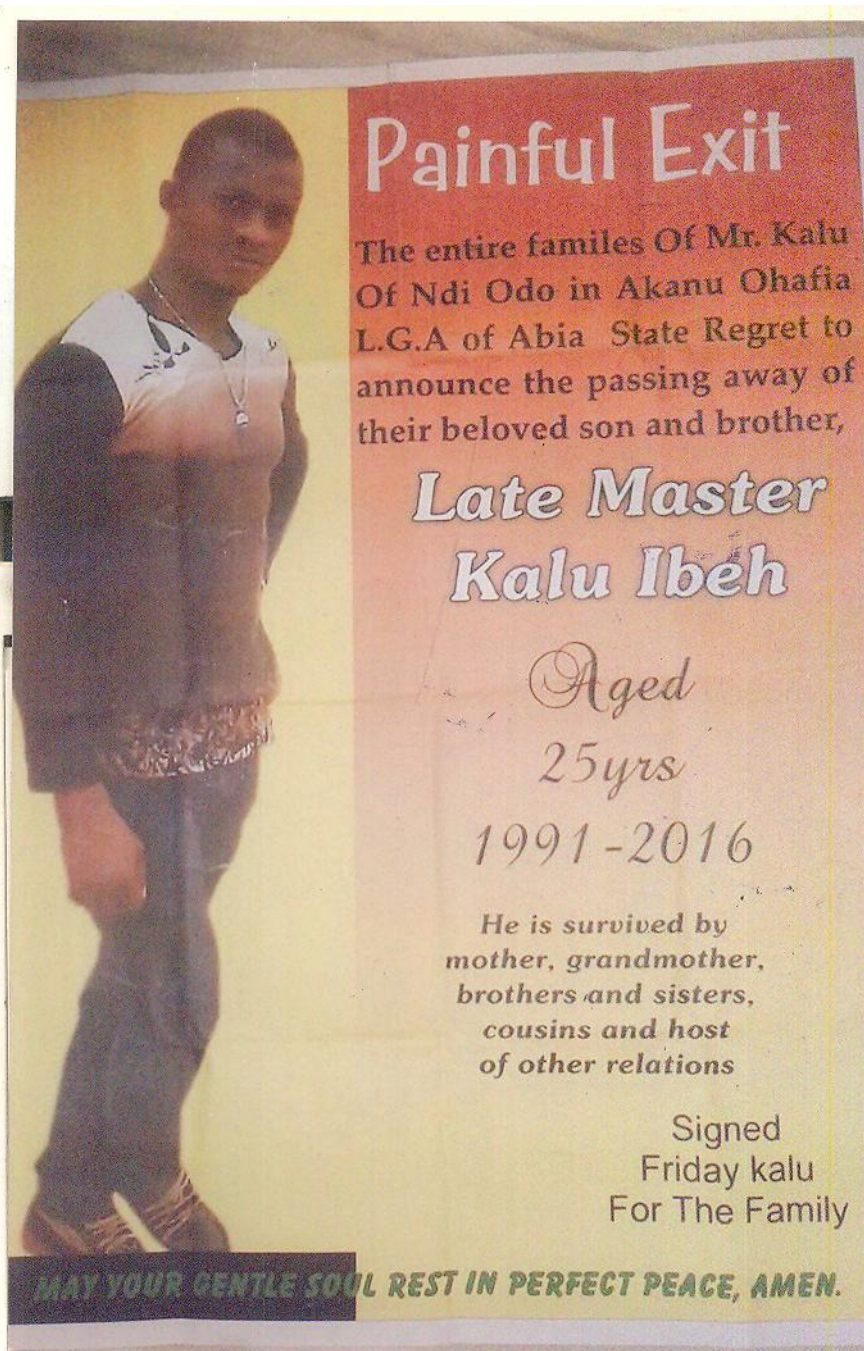

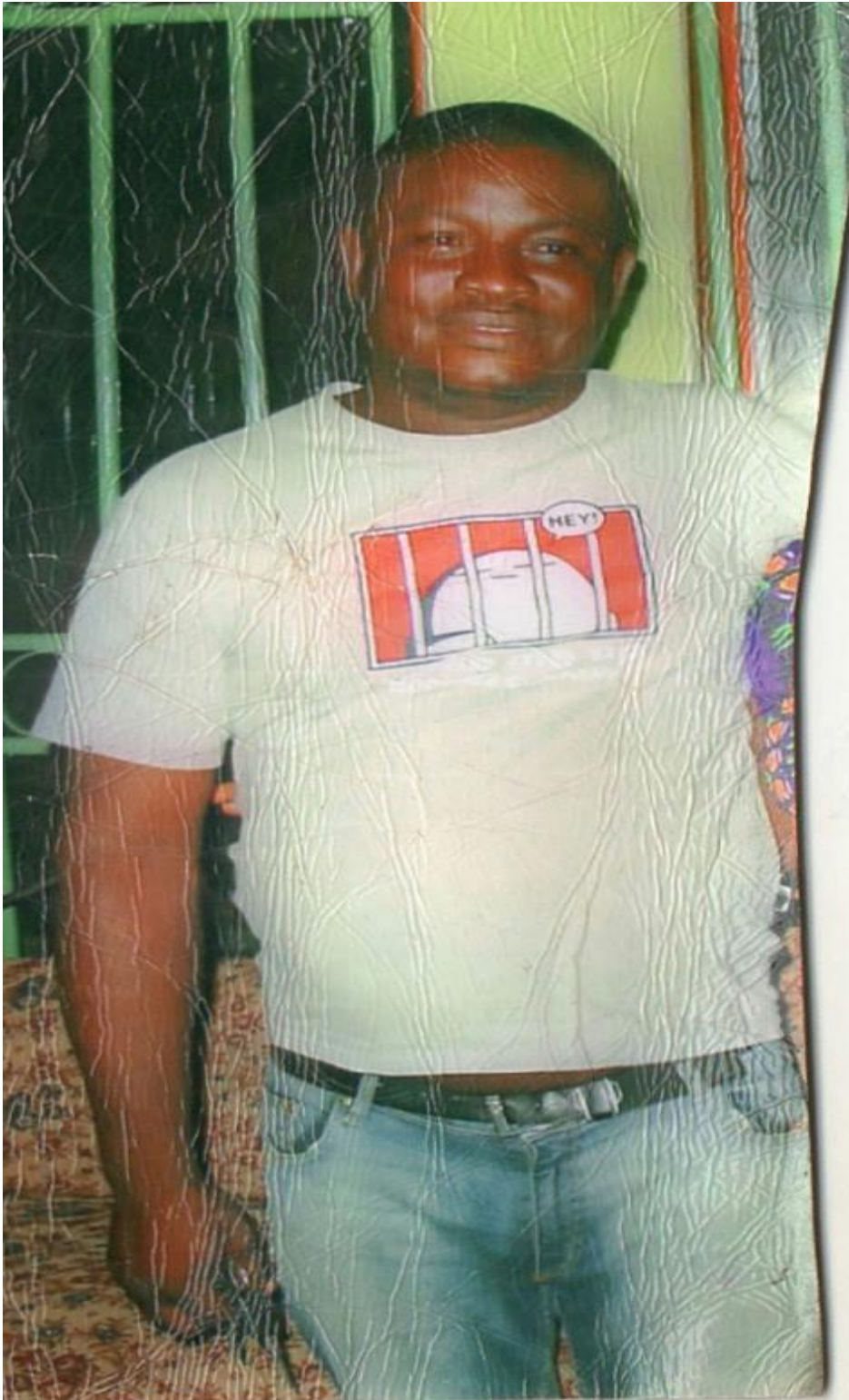

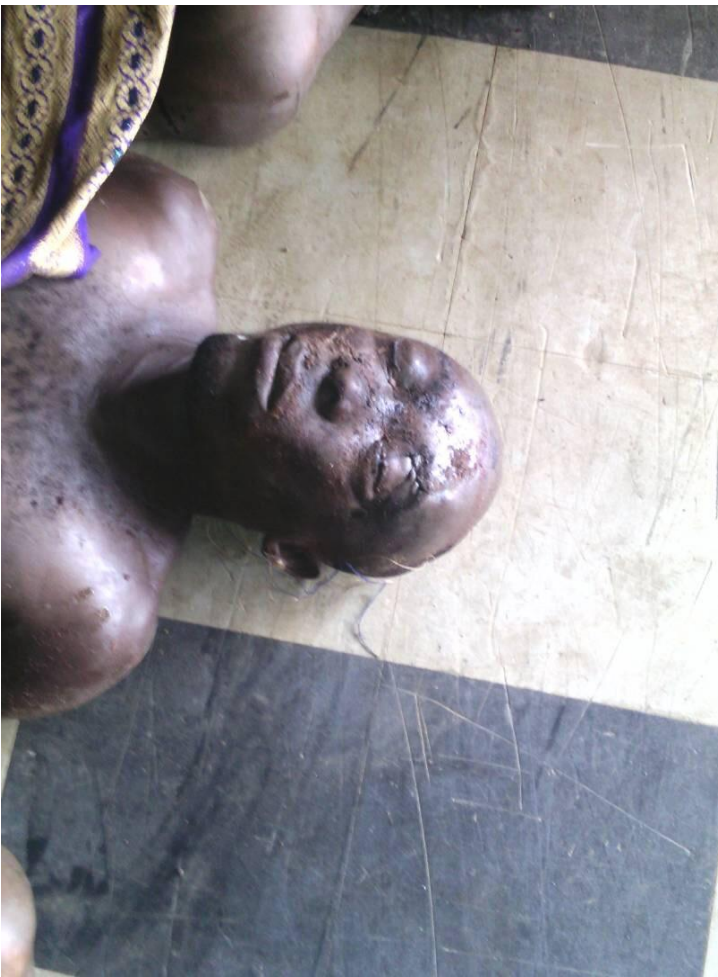

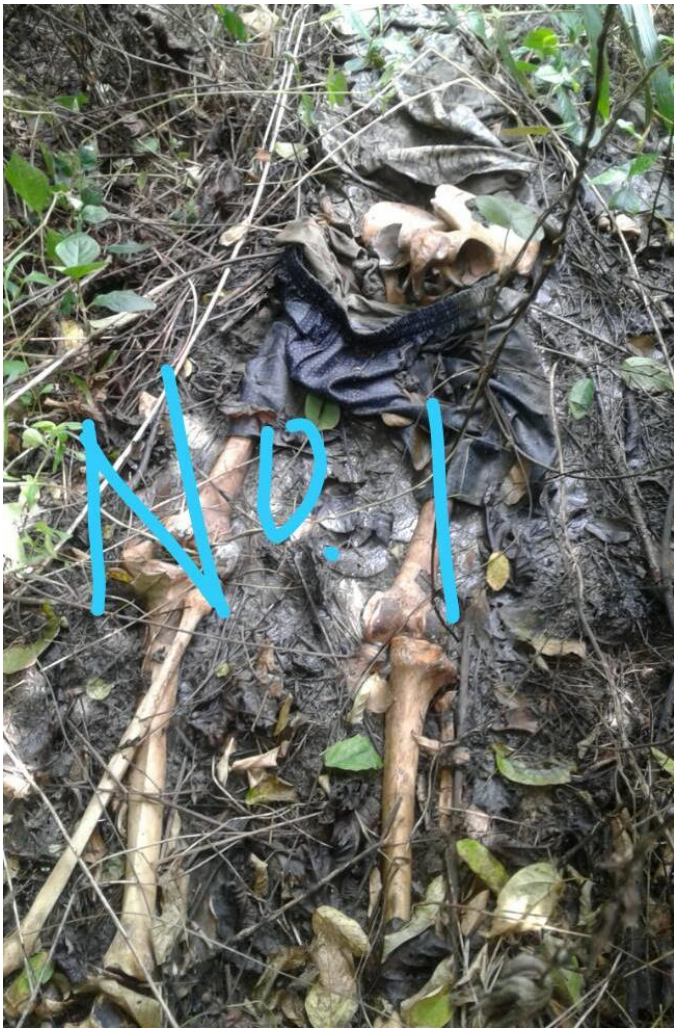

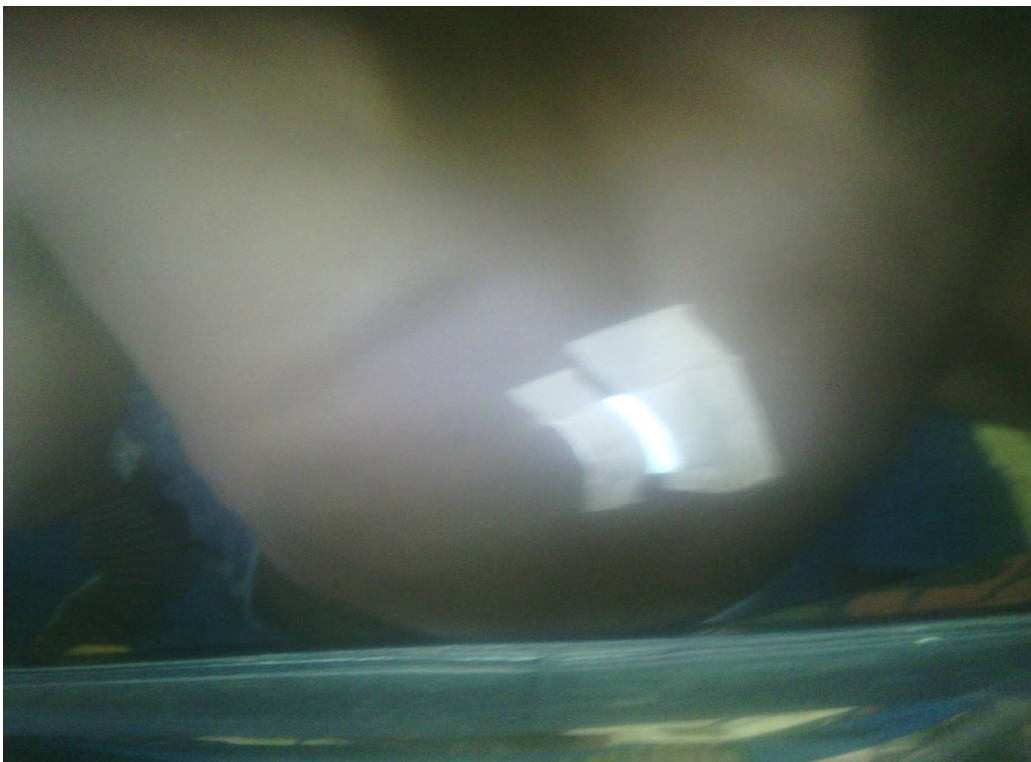

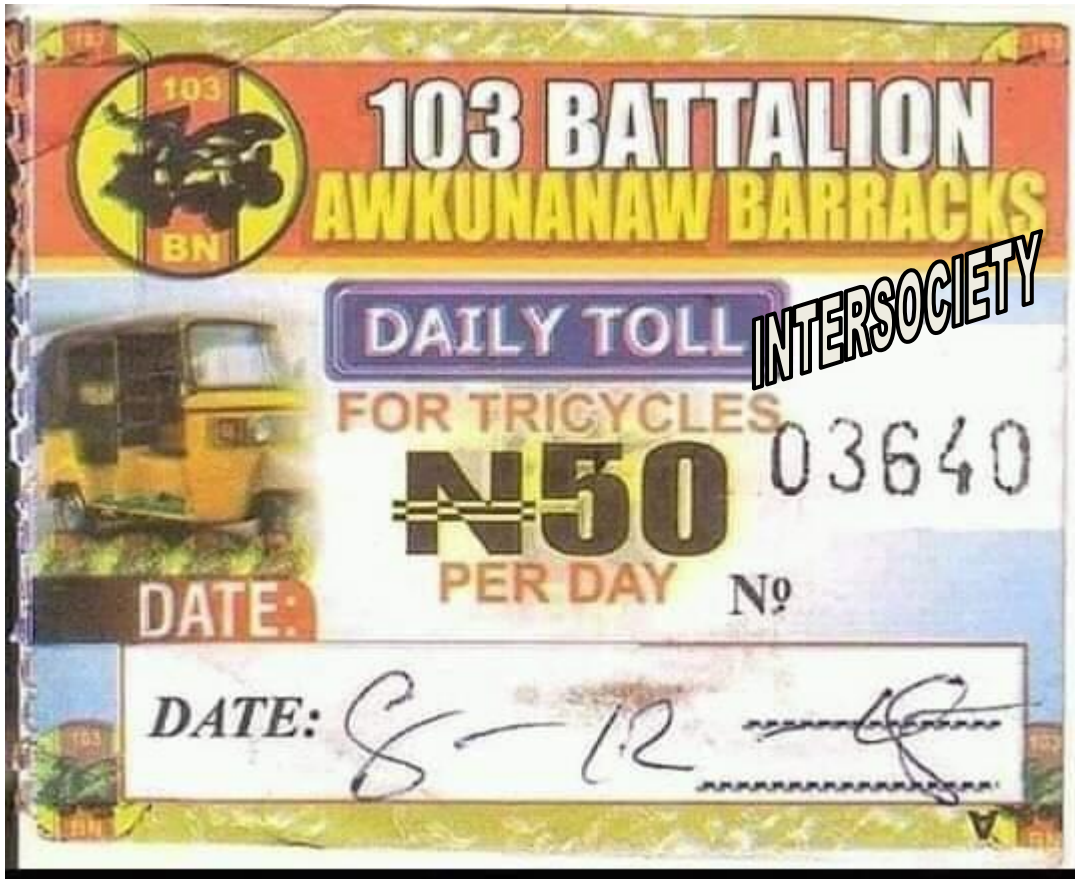
